## New Student

### Confirmation of Enrolment Fee

\$1,800 (non-refundable) to accompany acceptance of enrolment offer and secure the new student's placement.

### Advancement of School Fees

\$1,200 payable upon acceptance of enrolment offer. This amount will be credited against the student's fees after Term 2 of the enrolment year.

## Payment of fees and charges

The School offers families two methods of fee payment for annual tuition fees and levies, either 12 equal monthly instalments or annual prepayment of fees in advance.

Payments for 2020 fees and levies commence in October 2019.

The School accepts payment by direct debit only; either through a nominated financial institution or by credit card. Payments made by credit card will incur an 0.7% surcharge.

Invoices are issued at the end of each month, for tuition, levies and any additional co-curricular and extra-curricular charges incurred.

Full payment is due by direct debit on the 20th of the following month.
